What is STRIVE CCS?

STRIVE Comprehensive Community Services (CCS) is a program that provides mental health and substance use services in a manner which is Recovery Focused, Person Centered, Holistic, and Individualized.

Recovery Focused – This program is not about getting by. It's about getting better.

Person Centered – You have a voice and a choice. All services on your recovery plan are selected by you to meet your personal goals.

Holistic – Mental illness can affect all areas of your life, but that means recovery touches all areas of your life as well. Your plan can include physical health, mental health, social supports, spiritual health, employment goals, life satisfaction, and community involvement.

Individual – Your plan is about you and tailored to your individual recovery goals.

Am I Eligible?

STRIVE can serve individuals who meet all of the qualifications below:

- Reside in Vernon or Crawford County
- Eligible for and are willing to enroll in Medicaid—We will help you find out how and where to and apply!
- Have a mental illness or substance abuse addiction diagnosed by a qualified professional
- Need services (this is determined by a service facilitator using the MH/AODA Functional Screen)

How do I Apply?

- Complete an application
- Meet with a service facilitator. He/She will complete a “functional screen” to determine eligibility for the program.
- Start to think about what recovery looks like for YOU. Your service facilitator will help you with this process, but ultimately you will decide what success looks like. What do you want to be different in your life in six months? A year? Five years?
- Start to think about who can support you. Recovery involves healing and self-discovery, which can be rewarding to share with others. This can include friends, neighbors, family... whoever is important to you.

Participant's Rights

In addition to the rights granted under HFS 94, participants involved in CCS have the right to:

- Select recovery team members, services, and service providers
- Be informed about services as specifically, completely, and accurately as possible
- Appeal decisions regarding CCS determinations
