Jail

Jail Revenue

For Probation & Parole, our department houses extended supervision inmates that would normally get sent to prison.

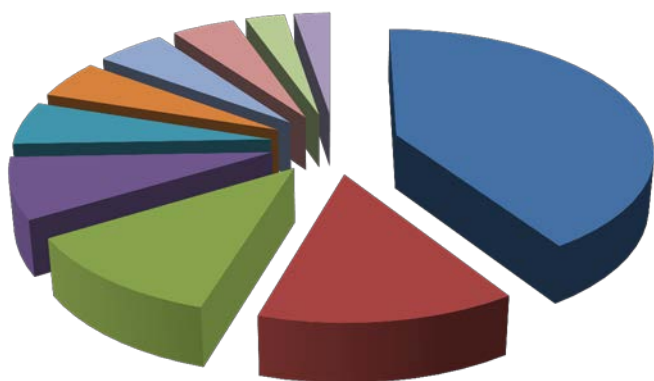
In 2012, \$38,451 was received for housing inmates.

Mental & Alcoholic Patients

Human Services has a contract with our department to transport individuals to Mayo Clinic for behavioral issues. In 2012 there was an increase of % from 2011.

In 2012, we served 30 individuals which involved 220 hours & were paid \$9,440. In 2011, the number transported was 28 for a total of 192 hours. \$8000 was collected.

Inmate Meals

In 2012, Aramark was contracted to make meals for the inmates. This created a substantial savings to the county. On a daily basis, a driver drives to and from Viroqua to deliver meals to our jail. While the breakfast & dinner are sack meals, evening meals are warm.

The cost of each meal is \$1.56. For 2011, 27,628 meals were served for \$102,973. In 2012 there was an increase to 29,576 meals. Our department recognized a 40% saving on the cost of inmate meals by switching to Aramark.

Criminal Investigations Division

The Crawford County Sheriff's Office Criminal Investigations Division consists of three Investigators whom are assigned complex cases which demand significant time & effort. Criminal Investigations Division relies upon skill, advanced technology & teamwork to bring justice to victims & hold offenders accountable for their crimes. The investigators are trained to handle a wide variety of investigations; however; each is trained & specializes in a certain area such as; narcotics, sensitive crimes, death investigations & property crimes.

Narcotics

Approximately 55 Narcotic related investigations were conducted by the Crawford County Sheriff's Office in 2012. These investigations included Meth, Heroin, Cocaine, Marijuana, & prescription medication abuse.

Sensitive Crimes

The Sensitive Crime Unit investigates sexual assaults, physical & sexual child abuse, internet crimes against child, elderly abuse, etc... The circumstances of these investigations are particularly difficult on the victim's, victim's families & friends, and the investigators.

Death Investigations

County Investigators are routinely required to respond to & perform death investigations when a human life unexpectedly expires within the county's jurisdiction. The investigation involves the process of determining the cause, identification, and the manner of death of the victim.

Property Crimes

A large amount of a County Investigator's time is focused on investigating a wide range of property crimes including; burglary, larceny, theft, motor vehicle theft, shoplifting and arson. The main objective of the investigator is to determine the identity of the offender & as a result of a thorough investigation, provide a solid case to the District Attorney's Office for prosecution.

Administration Support

Judgments The county received \$4,351 for judgments. This year we had 8 Executions Against Property, 8 Writ of Eviction, 12 Writ of Restitution, 8 Writ of Replevin & 4 Writ of Assistance.

Sheriff Sales A total of 57 Sheriff Sales were scheduled on 42 properties throughout 2012. Out of the 57 sales, 33 of them held, either went back to the bank or sold. Meanwhile, there were 24 sales that were either canceled or adjourned to another date. Posting and/or reposting a sale plus selling the property brought the county a revenue of \$8,700.

Year in Review

Each year brings with it new challenges, new highs and new lows.

This Year in Review gives a brief summary of our department activity in 2012.

January

- On 1/4/12, the Crawford County Sheriff's Office was called to assist the Fire Department & EMS with a boating accident that happened on the Mississippi River. The two gentlemen were successfully rescued from the icy water and transported to PdC Memorial Hospital for signs of hypothermia.

February

- Squad cameras were installed in all traffic vehicles.
- Training began for the Traffic & Criminal Software (TraCS) program. Once training is complete our deputies will be able to use TraCS full time & we will be able to phase out hand written reports.

March

- Deputy Cale Woodhouse resigned on 3/1/12 as a night traffic officer. Deputy Woodhouse had 12 years of service with Crawford County.
- The first fatality, a drowning in the Mississippi River on St. Feriole Island, occurred on 3/18/12.
- Deputy Nathan Bremmer, night jailer, was hired as night traffic officer to fill the vacancy of Deputy Woodhouse.

April

- Part time Deputy Shawn Lenzendorf was hired for night jailer to replace Deputy Bremmer.
- Deputy Kasie Moran was involved in an accident with her squad car.

May

- Deputies began using the computerized TraCs program for traffic crash reports and to issue citations.
- Deputy Kasie Moran was terminated on 5/4/12.
- Part time Deputy Joe Breeser was hired full time to fill the night traffic position vacated by Deputy Moran.

June

- A second fatality, an automobile accident, happened on June 5, 2012.
- Deputy Travis Koopman, a night dispatcher, resigned.
- Deputy Koopman's position was filled by Part Time Deputy, Karl Sander.

July

- A 2009 Tahoe vehicle was added to the fleet of vehicles. It replaced a 2008 Ford Explorer.

August

- On 8/10/12, there was a rock slide on Hwy 35 between the Falling Rock & CTH D. The Highway Department was called to the scene in order to clear the road. Deputy Nate Bremmer & a PdC Officer performed traffic control until all rocks were removed.
- Corrie Lawrence-Valley was hired part time to help with Administrative Assistant work.

September

- Mary Nash, worked for this department 33 years and retired on 1/31/09. Mary lost her battle with cancer on 9/6/12.

October

- On 10/3/12, there was an attempted homicide in rural Crawford County.

November

- Captain's Daughter, Yogis, & Carol's Two Rivers Bar burglary were all burglarized in one night. With the help of a citizen's tip, the subject was caught on scene.

December

- The third fatality, an automobile accident, occurred on 12/14/12.
